### Criterion – V 5. Student Support and Progression

5.1 Contribution of IQAC in enhancing awareness about Student Support Services

The IQAC is involved in all the management level meetings and provides inputs on academic, administrative, research and infrastructural needs. The IQAC monitors the feedback taken from the students and provides recommendations to the institutions for needful action on the same. The IQAC also works in co-ordination with sexual and gender harassment committee to address any grievance received by them. The IQAC also overlooks the anti-ragging committee activities to overcome any issues of ragging and if they are handled in the appropriate way.

Student Orientation programme held at the beginning of the academic year for undergraduate students, Orientation to Ethical issues and Guideline to be followed in Research to newly joined PGs. Timely updating of micro-schedules for theory classes. International, National and state level conferences as well as notices are displayed in the notice boards kept at vantage points.

The institution facilitates students to avail scholarship & other financial assistance from state government, central government and other authorities. Provides funds for the UG and PG level research projects at institutional level.

Builds a culture of social responsibility in Faculty and students through extension activities such as Swassthya Vidhya Vahini (SVV), Blood donation, Dental camps, donating funds to blind school and old age homes etc.

A new system of mentorship has been introduced by organizing a meeting of mentors and mentees during which about 400 students got introduced to 53 mentors.

'Driving license mela' was organized with the help of AP transport department in the campus on 24<sup>th</sup> Nov 2017 to provide learning license for the benefit of students and faculty.

Every year, college will organize an event for awarding the best library users in both students and faculty members to cultivate a habit of using library resources. This year it was done on 20th September 2017 at 2:00 PM in smart class room.

The Narayana Dental College celebrated the 12th Graduation Day on 08-11-2017 (Wednesday). As many as 89 BDS Students, who passed out in 2017, received their certificates. Prof. Dr.Thyagarajan, Professor of Eminence & Dean (Research), Sri Ramachandra University was the Chief Guest of this event.

5.2 Efforts made by the institution for tracking the progression

Institution's efforts in tracking the progression are continuous & retrospective. The approach to track the progress of students is as follows

1) The institution enrols all the successful under graduates and post graduates into alumni association and the students also register their details into the website, the automatically generated username and passwords will be sent to registered alumni member to remain in contact with their alma mater and post updates. Formal social gathering of the alumni is being tracked with the help of social networks like Whatsapp, face book etc. This year the alumni meet was conducted successfully on 4<sup>th</sup> March 2018.

2) Regular monitoring of peers for their regularity in attending the classes closely on an hourly basis and learning through the Mentorship Programme and intimated to the parent immediately.

3) Monthly attendance and marks are compiled as student's reports and sent to parents and students.

4) All the mentors maintain mentoring booklet, in which he/she updates details of academic performance of the mentees to compare and discuss their performance, attendance % and progress of the students in their exams and other academic activities.

5) Slow learners lists were prepared and counseling done by the Committee members. Remedial sessions were conducted for the Slow learners with schedules, repeated exams & counseling's by Incharge staff members.

6) Mentors offer academic counseling to students, recommend them for remedial coaching if necessary, and also meet/communicate with parents of their mentees to update them on their progress.

7) Following the final university results the marks of the students were analyzed both at the state and institutional.

8) Monitors the feedback taken from the students and provides needful action on the same.
